**15. NEW BUSINESS – (Ordinances – First Reading)**

- a. Ordinance to appropriate \$2,407,197 in funding in the Capital Projects, Hospitality Tax and Local Accommodations Tax funds for construction of Swamp Rabbit Trail pedestrian bridges  
*(Presented by OMB Deputy Director Karen Crawford)*

Councilmember Stall moved, seconded by Councilmember DeWorken, to approve first reading.

Councilmember Dowe asked about the County's responsibility involving the Woodruff Road Bridge. Interim Engineering Services Manager/City Engineer Clint Link responded the County's responsibility is to provide upgrades to the existing bridge. Mr. Link advised that he has spoken with Ty Houck who advised the County is entering into negotiations with Palmetto Infrastructure to perform work on the bridge that will include new hand rails, new decks, and other miscellaneous upgrades. Councilmember Dowe noted that the trail cannot open until the County completes that work.

Councilmember Gibson stated that he believes the money would still be better used spreading it out throughout all the crossings, however, with the passage of the Resolution at the last meeting, he will be supporting this Ordinance.

After discussion, the motion carried unanimously.

**16. NEW BUSINESS – (Resolution – First and Final Reading)**

- a. Resolution to request the removal of an approximate 3.20-mile section of Augusta Street (SC-20 and S-201) from the State Highway System  
*(Presented by Interim Engineering Services Manager/City Engineer Clint Link)*

Councilmember Gibson moved, seconded by Councilmember Brasington, to approve first and final reading.

Councilmember Stall asked how likely it is for SCDOT to approve this matter. Mr. Link responded that based on history, SCDOT is usually willing to give up right of ways. Mr. Link stated Augusta Street is an important road in their network and they may review the matter more than usual. Councilmember Dowe asked if the City is in its purview to ask for compensation given the maintenance requirements and drainage conditions, and Mr. Link responded affirmatively.

After discussions, the motion carried unanimously.

Council members expressed their gratitude for staff for their work involving Fall for Greenville which was held over the weekend.
